Word of mayor

Dear citizens,

Once again, it is with great pleasure that I address you through our municipal newsletter.

The summer season is already over and we are preparing for winter and its storms. At the municipal level, we are in the process of putting in place an emergency plan to be able to respond quickly and effectively to emergencies; our priority is to ensure the safety of our people.



In terms of infrastructure development and improvement, three projects will be completed by spring 2020; either the renovation of our La Souche Outdoor Centre, the renovation of the Port-Daniel wharf located to the west of our cultural space and the upgrade of the Anse-à-la-barbe wharf.

With regard to these projects, the work of the La Souche Outdoor Centre will be paid for through the government's Gas Tax Return Program, the upgrade of the Anse-à-la-barbe wharf will be funded by Fisheries and Oceans Canada, and the repair of the Port Daniel wharf by a municipal borrowing by-law.

For the year 2020, we should proceed with the renovation and expansion of the Multifunctional Center and work on the implementation of the seniors' residence should begin. We are also analyzing the presentation of a project to improve our municipal arena.



In addition, we are seriously looking at changing the lighting of our streets through LED lighting. In this regard, studies show that the return on our investment will be within the first five years, due to significant savings in electricity costs and repair and maintenance costs.





Regarding the water and sewer project in the Gascons sector, the plans and specifications for construction will be completed and we will be able to launch the calls for tenders.

In fact, we are continuing our work to increase the quality of life of our residents, meet the needs of our people and increase the attractiveness of our municipality.

Finally, I join the members of the municipal council and the employees to offer you our greetings and wish you a beautiful autumn.

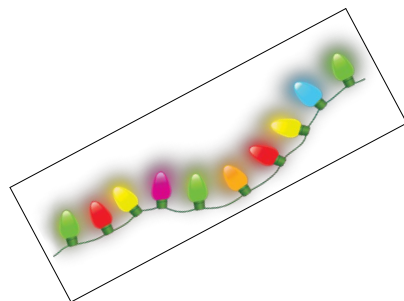
FAMILY CONTEST

POPULATION ALERT SYSTEM

IN EMERGENCY SITUATION

WHAT?

The Municipality of Port-Daniel-Gascons in partnership with the municipalities of the MRC have signed a service agreement for the implementation of the application "Web Memento Emergency" allowing citizens to register for a mailing list to receive alerts from municipal authorities when a so-called urgent situation arises.

WHY?

The municipality of Port-Daniel-Gascons will be able to broadcast alert messages via text or SMS on cell phones to inform or alert in case of breakdowns or urgent disasters such as:

⇒ notices of non-consumption of water

⇒ Boil water advisories

⇒ Evacuation notices

⇒ Power outages

⇒ Or any other emergency

The municipality will be able to target a particular area or the general population to advise them of the situation and what action to take.

For this alert to be effective, you need to be registered with the automated alert system to receive messages.

HOW TO REGISTER ?

Click on the Link: Memento **Alerte SMS publique** and fill in all the requested fields.

At any time, you can change the data listed and you need to make sure your contact information is updated.

YOUR CIVIC NUMBER

We would like to remind you of the importance of properly identifying your buildings. Civic numbers are of paramount importance in an emergency.

If the emergency services have to look for the civic number because:

- ⇒ It is poorly located
- ⇒ It's too small
- ⇒ The number is incomplete
- ⇒ It's poorly lit



This can result in the loss of precious minutes in an emergency.



YOUR CIVIC NUMBER MUST BE:

IN FRONT OF YOUR BUILDING

Visible from the public road day and night

If possible well lit

Article 5: Snow Deposit

During the snow removal of parking lots, driveways entrances or private properties, no one may deposit this snow near the fire hydrants, on roads and roads maintained by the municipality in such a way to encumber the roadway or to reduce the width road.



Article 6: Parking forbidden

It is strictly forbidden to park any motor vehicle within the right-of-way of municipal roads, as well as in the routes at the end of these roads and paths, in order not to interfere with the snow removal operations that are carried out there. Any vehicle so parked will be towed at the expense of its owner.

NOTE: special attention will be paid in the roads giving access to a sport building.

Article 7: Offender to the regulation

Is liable to the penalties laid down by the regulation, anyone who prevents or harms the work of the municipality or of his representative or anyone who contravenes any other article set out in the regulations.

A Word from Alexandre Rail, McInnis Cement's Vice President-Operations

Good day!

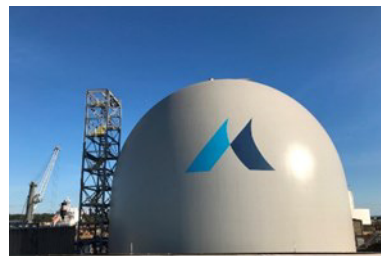
After a busy summer for the company, I am pleased to send you a status report on our various projects, both those of the plant and our work in our US terminals.

Two Major Projects at the Bronx and in Providence

Commenced in the winter of 2019, work at the Bronx terminal has been completed in the last few months. The New York market being particularly active, we had to quickly put into service a second loading lane for the trucks that come to take delivery of our cement for their various projects. This work has been accomplished and permits accommodating more trucks in a single day, being able to simultaneously load two trucks at a time.



At Providence, the construction is in full swing and will continue throughout the winter. This terminal will see its storage capacity virtually double, from 40,000 to 75,000 metric tons, thanks to the installation of a dome that already wears our colors, as you can see in the photo. As is the case in the Bronx, a second truck loading lane will also be added, making Providence the largest cement terminal in this region in terms of storage capacity.



Two New Silos at the Plant

Here also, the new investments confirmed by our shareholders at the beginning of the summer were felt on the ground. You will probably have noticed the change, even by far, with the addition of two new cement silos near the marine terminal. Always impressive, the work consisted of a continuous concrete pouring for the new infrastructures, day and night, for two weeks. This pivotal step has been successfully completed and the construction team is continuing the work to finish over the winter so that we can

start using both silos by next spring's construction season.

I am delighted that our business model, with the plant and distribution, is gaining stability and flexibility, which is a guarantee of success for the future.

REGARDING DOGS

Article 9 : Nuisance:

The following facts, circumstances, actions and acts are nuisances and are, as such, prohibited, and the keeper himself who is the author of such nuisance or whose animal acts in such a manner as to constitute such nuisance, contravenes this regulation and is Subject to the penalty imposed by this Regulation:

Any dog yapping, groaning or emitting sounds in such a way as to disturb the peace or to be a serious annoyance to the neighborhood;

Any dog pursuing, attacking or injuring a pedestrian, cyclist or other domestic animal;

The presence of a dog without a guard outside the limits of the property of the keeper;

The fact for a dog to bite, to try to bite a person or an animal;

The presence of a dog without a guard, not kept on a leash by his keeper, outside the property of the keeper;

The presence of a dog without a keeper, on the property of the guard, when the dog is not attached or the keeper's property is not sufficiently fenced to contain the dog;

The presence of a dog on a playground of the municipality or in a building of the municipality with the exception of guide dogs;

The presence of a dog on private land without the consent of the occupant of that land;

The refusal by the keeper of a dog to allow the competent authority to enter his home to observe compliance with this Regulation.

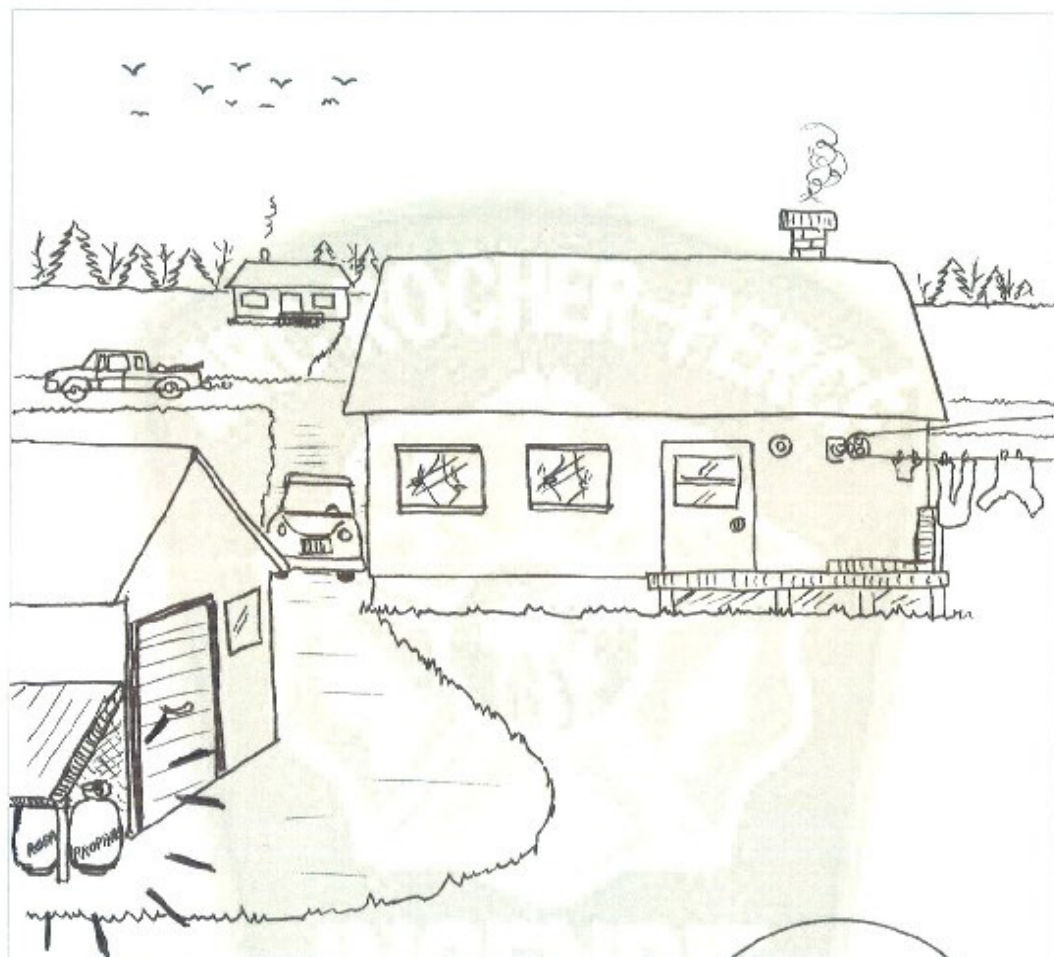
Article 18: Guard

Any animal kept outside a building must be held or restrained by means of a device (clip, leash) preventing it from leaving the field



Any person who contravenes any provision of this regulation commits an offense and is liable to a fine.

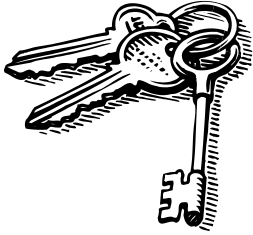
