REMORQUES, CONTENEURS ET AUTRES TYPES DE BÂTIMENTS PROHIBÉS

ILLEGAL CONNECTION TO THE PUBLIC SANITARY SEWER SYSTEM

RECALL-RECALL-RECALL

The purpose of this reminder is, that a volume of water too high of illegal drainage in the pumping stations, cause overflows.

EXTRACTED FROM REGULATION NO. 2014-05 CONCERNING THE ADMINISTRATION OF WATERWORKS AND SEWER SYSTEMS

Article 5: Requirement for a connection to sewers (sanitary or rain):

- 5.1 Every owner of a building served by the municipal sewer service must install, at his own expense and maintain in good working order, a safety valve (no-return valve) to prevent any back-up of sewage.
- 5.5 In the event of failure by the owner to install and maintain such valves (non-return valve) in good condition in accordance with this by-law, the municipality is not liable for damage caused to the building or its contents as a result of a sewer water backup.

Article 6: Protection and maintenance of water and sewer equipment

6.4 It is strictly forbidden to connect any basement drain or storm drain to the public sanitary sewer system.

Article 7: Supervision

7.4 The officers of the municipality responsible for the water and sewer service shall be entitled between 7 a.m. and 7 p.m. to visit any immovable property as well as the interior and exterior of any building served by the said networks in order to ascertain the condition of the piping and the appliances connected to it and to see if the water is not wasted, make a census or for any other cause related to the water and sewer

Article 8: Rights and powers of the municipality

8.4 The Municipality of Port-Daniel-Gascons will not be liable for damage caused by the discharge of public sewage into buildings when such damage has been caused by the absence, defect or malfunction of valves or other automatic safety devices on the private drains of any construction.

Article 15: Criminal sanctions

- 15.1 Every person who contravenes the provisions of these Regulations is guilty of an offence and is liable to the following minimum and maximum fines:
- (1) for a first offence, a minimum fine of \$100 and a maximum fine of \$150, plus fees; (2) for a second offence under a provision of the regulation, to which he had pleaded guilty or had been found guilty for at least twelve months from the date of sentencing (on the second offence), a fine of not less than \$150 and a maximum fine of \$250, plus costs
- (3) for any offence under any provision of these Rules to which he had pleaded guilty or had been found guilty, on two or more occasions, for at least twelve months from the date of sentencing (on any offence subsequent to the second) of a minimum fine of \$250 and not more than \$300, plus costs.

PUBLIC ALERT SYSTEM IN AN EMERGENCY

The municipality of Port-Daniel-Gascons in partnership with the municipalities of the MRC du Rocher-Percé have signed a service agreement for the implementation of the *Memento Urgence web* application allowing citizens to register for a mailing list to receive alerts from the municipal authorities when a so-called emergency situation arises.

WHAT FOR?

The municipality of Port-Daniel-Gascons will be able to broadcast alert messages via SMS on cell phones to inform or alert in case of breakage or urgent disaster such as:

- → Notices of non-consumption of water
- → Boil water advisories
- → Evacuation notices
- → Power outages
- → Or any other emergency situation

The municipality may target a particular sector or the entire population to inform them of the situation and the measures to be taken. For this means of alert to be effective, it is necessary to be registered with the automated alert system to receive messages.

How do I register?

Go to the Memento Public SMS Alertwebsite, choose the MRC du Rocher-Percé and the municipality of Port-Daniel-Gascons, the sector (Port-Daniel or Gascons) and fill in all the fields requested. At any time, you can change the data entered and you must ensure that your contact information is updated.
